Be it enacted and ordained by the Board of Supervisors of West Caln Township, Chester County, Pennsylvania, and it is here-by enacted and ordained by the authority of the same.

This is an ordinaance adopting and authorizing the use by peace officers of traffic speed timing devices as prescribed by Title 75 PA. C.S.A. § 3368 of the Vehicle Code (of the State of Pennsylvania).

The Supervisors of the Township of West Caln, Chester County,

Pennsylvania hereby enact the following ordinance which shall form a

part of the Code of West Caln Township, Chester County, Pennsylvania.

SECTION 1. This ordinance shall be known as the Traffic Speed Ordinance for Timing Devices as authorized by the Title 75 PA. C.S.A. § 3368 of the Vehicle Code.

SECTION 2. The Supervisors of the Township of West Caln, Chester County, Pennsylvania approve and authorize the police officers of the Township of West Caln to use mechanical and electrical speed timing devices in order to regulate speed of vehicles upon the streets of the Township. This ordinance shall be in conformity to 75 PA. C.S.A. § 6101 et seq., providing the requirement of enacting an ordinance to use said devices, which are authorized under 75 PA. C.S.A. § 3368.

SECTION 3. The words and phrases used in this ordinance shall have the meaning respectively ascribed to them in the Vehicle Code (of the State of Pennsylvania) Act 81, Chapter, \$ 102, its supplements and amendments.

SECTION 4. The Supervisors of West Caln Township, Chester County, Pennsylvania hereby declare that they have approved the use of speed timing devices to aid in the enforcement of the Township and/or State of Pennsylvania's speed restrictions.

.

SECTION 5. The types of speed timing devices which can be used shall be either mechanical or electrical timing devices which either are approved or approved in the future by the Department, as provided in 75 PA. C.S.A. \$ 3368 (The Vehicle Code). For example and not by way of limitation the Supervisors of West Caln Township, Chester County, Pennsylvania specifically authorize the use of the______

The above speed timing device was approved under the provisions of 75 PA. C.S.A. $_{\rm s}^{\rm S}$ 3368 (d) by the Department on May 17, 1981.

SECTION 6. The police officers of the Township of West Caln, Chester County, Pennsylvania are tuthorized and directed to use the approved speed timing device to aid in the enforcement of the Township's and State of Pennsylvania's speed restrictions.

SECTION 7. Signs shall be errected which are legible and in conformity with existing law and regulations giving public notice of the use of speed timing devices and shall be posted at or near the public highways and at the boundries of said roads leading into the Township.
