ORDINANCE NO. 02 – 2024

AN ORDINANCE OF THE TOWNSHIP OF WEST CALN, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE WEST CALN TOWNSHIP CODE AT CHAPTER 252 PARKS AND RECREATION AREAS TO REVISE SECTION 252-1 TO ALLOW FOR ALCOHOL TO BE SERVED AS PART OF CERTAIN SPECIAL EVENTS SANCTIONED AND APPROVED BY THE TOWNSHIP AND PROVIDE FOR SEVERABILITY, REPEALER AND EFFECTIVE DATE PROVISIONS.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of West Caln Township that Chapter 252 of the Township Code, as amended, is hereby further amended as follows:

SECTION 1. Section 252-1.N shall be revised to read in its entirety as follows:

N. Alcohol, drug and smoking prohibited. Alcohol use, drug use and smoking are prohibited in the parks. No person shall bring any alcoholic beverages or drugs into the parks, either for his own use or for the use of any other person. No smoking is permitted in the parks. Violation of this provision shall subject the violator to expulsion from the parks. Alcohol may be served, permitted and allowed in areas designated as part of a special event approved by the West Caln Township Board of Supervisors and, if required by law, with the appropriate permitting from the State Liquor Control Board, and also with the proper insurance coverage in place which may include naming the Township as additionally insured.

SECTION 2. Severability. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.


SECTION 3. Repealer. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 4. General Code. General Code is hereby authorized to make whatever numbering and formatting changes are needed in order to properly codify this ordinance and properly incorporate this ordinance into the Township's online Code.

SECTION 5. Effective Date. This Ordinance shall be effective as provided by law.
