These are updates to our current MS4 permit with the State which will be projects spread out over the next 5 years to help sediment flows into the Chesapeake.

Public Comments received from:

Sally Minninger- Stated she had previously reviewed the MS4 document posted on website but did
not understand it initially. Acknowledged that after Mr. Daley's presentation it made more sense.
 Sally inquired whether any of these requirements and changes and redirection of water that need

to be made would diminish any waterways? Mr. Dalen responded that with the proposed options no water would be redirected they are simply measures to reduce sediment and pollution to the watershed. Ms. Minninger inquired whether the township could just opt to not make these improvements? Mr. Daley stated this was not an option since this is mandated through PA DEP.

- 2. Bill Spivey- Asked if the township meeting with DEP regarding this MS4 update would be open to the public or if the township planning commission would be involved in some way? Mr. Daley stated that the meeting with the DEP would not be open to the public, it would be a meeting with himself, township staff and DEP. The Board of supervisors would make a determination whether they would want the planning commission involved. Mr. Spivey also asked whether any of these improvements made as part of the MS4 update would help with water runoff on the township roads. Mr. Daley stated that was not the purpose of these updates.
- 3. Patrick Warren- Asked if the township had an expected time frame on when the options and costs would be available for these updates? Mr. Daley stated that this will be worked on beginning now and continue over the next two years so the Board can budget and potentially obtain any available grant money to offset costs to the township for any improvements.
